Plus ONE of the below:
A) Disabled child premium
B) Has parental responsibility for a child under 16 that lives at the property
C) Has parental responsibility for a child who is 16 or over but under 20 and in full-time education other than higher education that lives at the property
D) Pension premium, higher pension premium or enhanced pension premium
E) In receipt of child tax credit which includes a disability or severe disability element
F) Disability premium, enhanced disability premium or severe disability premium
G) Receiving a work related activity or support component (only with Number 2)

Combination Benefit 2:
1) Working Tax Credit relevant income below £15,860
Plus ONE of the below:
A) Has parental responsibility for a child under 16 that lives at the property
B) Has parental responsibility for a child who is 16 or over but under 20 and in receipt of a disabled worker element or severe disability element.
D) Aged 60 or over
Please note that the Combination 1 and Combination 2 section cannot be mixed.
